Dear Mr. Ross:

On November 5, 1982, we met to discuss the above-captioned grievance at the fourth step of our contractual grievance procedure.

The matters presented by you as well as the applicable contractual provisions have been reviewed and given careful consideration.

The question in this grievance is whether or not management violated Article 25 of the National Agreement by not compensating Vehicle Operations Assistants--Bulk Mails at a higher level for time spent using the radio to dispatch in-yard vehicles.

Based on a review of available information, it is the position of the Postal Service that higher level pay is not warranted for performing the duties described. No information was provided which would establish that the duties being performed were beyond the scope of those described in the position description for Vehicle Operations Assistants.

Accordingly, as we find no violation of the National Agreement, this grievance is denied.

On July 9, 1985, we met to discuss the above-captioned grievance at the fourth step of our contractual grievance procedure.

The issue in this grievance is whether the duties in question warrant higher level pay.

After reviewing this matter, we mutually agreed that no national interpretive issue is fairly presented in this case. Whether the grievant's task of accepting money from each clerk at the Main Office on Saturdays warrants higher level pay is an issue suitable for regional determination based upon the specific fact circumstances.

Accordingly, we agreed to remand this case to the parties at Step 3 for further processing including arbitration, if necessary.
