

Dear Mr. Wilson:

On April 17 and June 8, 1983, we met to discuss the above-captioned grievance at the fourth step of our contractual grievance procedure.

The question raised in this grievance is whether an employee can be detailed to a supervisory position for a portion of a tour and assigned to perform bargaining-unit work for a portion of the same tour.

During our discussion, we agreed that while there is no contractual prohibition against an employee serving in a supervisory status for a portion of a day, normally an employee who is detailed as an acting supervisor will not perform bargaining-unit work prior to the workday immediately following the termination of the detail. Because the information presented in this case did not establish a conflict with the foregoing, we agreed to close this case with the understanding that the fact circumstances in each similar case must be examined in order to make a determination whenever this question is raised.

Please sign and return the enclosed copy of this decision as your acknowledgment of agreement to close this case.

The time limit for processing this case was extended by mutual consent.
