Dear Mr. Tunstall:

On May 7, 1986, we met to discuss the above-captioned grievance at the fourth step of our contractual grievance procedure.

The issue in this grievance is whether a job posting which includes a rotating schedule must reflect the actual nonscheduled days.

During our discussion, we mutually agreed that the following constitutes full and final settlement of this case:

When future jobs are posted with rotating days off, the vacancy announcement shall specifically indicate which cycle of rotating days the position requires.

Please sign and return the enclosed copy of this letter as your acknowledgment of agreement to settle this case.

Time limits were extended by mutual consent.
