This is an update to the correspondence dated August 11<sup>th</sup> regarding Federal employees on temporary appointment including, non-career employees, now eligible to voluntarily enroll in a Federal Employee Dental and Vision Insurance Plan (FEDVIP) program.

The FEDVIP enrollment period for existing non-career employees has changed. The enrollment period opened August 11<sup>th</sup> and will now remain open through Sunday, October 10, 2023, two weeks longer than originally communicated.

# Special enrollment period extended for pre-career employees to participate in dental, vision benefits.

The Postal Service announced on August 11, 2023, that pre-career employees are now eligible for the Federal Employee Dental and Vision Insurance Program (FEDVIP).

The special enrollment period for pre-career employees has been extended through October 10, 2023. After that date, you will only be able to enroll during the annual benefits open season or within 60 days of a qualifying life event.
