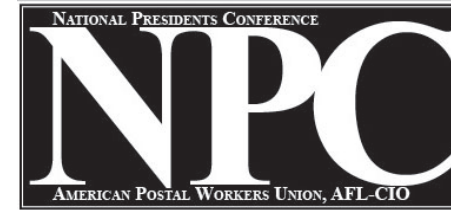

Dear APWU President;

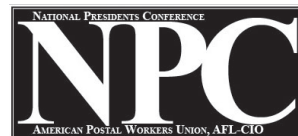
Our first Conference of 2020 will be "Springtime in the Rockies" hosted by the Colorado Springs Area Local at the Hotel Elegante Conference and Event Center in Colorado Springs Colorado March 21-23. The day of training Saturday the 21<sup>st</sup> is projected to have two separate sessions, one for Unfair Labor Practice Charge training and the other for anticipated new CBA provisions. Every State and Local President belongs at the Conference and is encouraged to participate. The NPC formally convenes three (3) times a year, rotating around the Country.

The registration fee is \$100.00 per attendee (Delegates, Alternate Delegates, Observers, and Guests); however registrations made after Thursday March 19<sup>th</sup> are subject to the late registration rate of \$125.00. **No National Officer can be a Delegate or Alternate Delegate under any circumstances.** Participants are responsible for making their own hotel reservations. State and Local Presidents (or their designees) are encouraged to submit agenda items for discussion and debate during the Conference on Sunday and Monday. Agenda items are categorized by Constitutional issues; Internal APWU issues; (legislative, national political) Collective Bargaining issues; National Negotiation issues and others. The best way to submit agenda items is by e-mail to the Chairperson or Vice-Chairperson at the addresses listed below. Please note: In order to secure your agenda item being sequenced and pre-printed in the handout it must be received no later than 5:00 PM (ET) Friday March 13, 2020. You should also prepare to bring sufficient copies of handouts for items not timely submitted.

Make note of future NPC Conferences: After Colorado Springs the next scheduled Conference takes place June 20-22 in Chicago, Illinois; we'll then meet informally in Los Angeles in conjunction with the National Convention probably August 14-15, then back on regular rotation to the Eastern Region in Niagara Falls, New York from October 24-26. Our March Washington, DC Legislative Conference will kick off 2021.

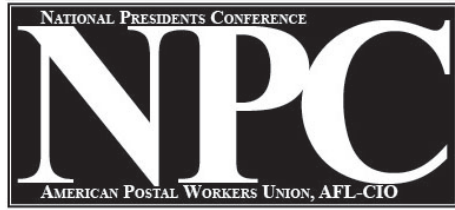
