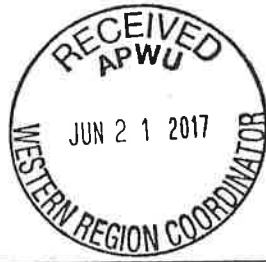


This is to advise you of the intent of the Sierra Coastal District to utilize the provisions of Article 12.5.C.5 of the National Agreement to involuntarily reassign up to three (3) full-time clerks from the craft and/or installation at the Bakersfield bid installation (Event 55854) based upon a loss of workload. Specifically, the career staffing exceeds the required staffing based on the current workload.

The impacted employees will be notified of their involuntary reassignments by separate letter.

By copy of this notice, we will withhold three (3) full-time residual assignments in the clerk, carrier, mail handler, and/or custodial crafts in the sites within a 50 mile radius of the impacted bid cluster for placement of the impacted employees.

Attached you will find copies of the automated impact statement, the operational data that supports the excessing event, the list of sites at which withholding has been authorized and the names of the junior impacted employees.
