In order to minimize the impact due to the operational change we are authorizing the withholding of two (2) Full Time Level 6 clerk residual vacancies at the same (Level 6) or lower level in surrounding installations within a 50 mile radius. These positions include clerk, carrier, mail handler and maintenance craft positions.
