Dear Ms. Stone:

On August 23, 2013, you were informed with a notice of the workload reduction at the Devils Lake, ND Post Office. In that notice two (2) Full-time Clerks were impacted, which one (1) reassigned to the carrier craft effective November 2, 2013. Therefore, one (1) Full-time Clerk continues to be impacted from this event.

This notice is due to ongoing operational changes (F-4 Review). We are authorizing the withholding of an additional one (1) Full-time Clerk, Level 6 residual vacancy at the same (Level 6) or lower level in surrounding installations within a 50-mile radius of the Devils Lake, ND Post Office. We are combining both events and withholding a total of two (2) residual vacancies which includes clerk, custodian, letter carrier and mail handler crafts positions.
