This letter is with regard to the workload reduction at the Phoenix, AZ Post Office. In order to minimize impact due to the workload reductions we are authorizing the withholding of twenty eight (28) Full Time Level 6 and three (3) Level 7 clerk residual vacancies at the same or lower level in surrounding installations within a 50 mile radius. These positions include clerk, carrier, mail handler and custodial craft positions.
