This is in further reference to the Postal Service's ongoing correspondences on establishment of Sorting and Delivery Centers (S&DCs). The purpose of establishing S&DCs is to reduce transportation and mail handling costs as well as provide postal customers with additional services. S&DCs will allow for easier standardization and management of operations will have improved building and operating conditions for employees.

This notice is to provide you with information on future sites identified for conversion to S&DCs during 2025-2027. While the Postal Service does not intend to relocate operations from other spoke sites, future studies may result in changes.
